EXECUTIVE SUMMARY

The year 2024 marked a period of significant transformation for CIRDAP, highlighting key activities, notable achievements, and important challenges. As an Intergovernmental and autonomous organization, CIRDAP made its path stronger to strengthen its role in advancing Integrated Rural Development (IRD). Through collaborative efforts with its member countries, the organization made meaningful strides in reaching and positively impacting the lives of thousands of rural people across the Asia-Pacific region. All activities during the year were carried out in alignment with the approved Strategic Plan of CIRDAP.

One of the most significant developments of CIRDAP in 2024 was a change in leadership. Dr. P. Chandra Shekara, an Indian national, assumed charge as the 10th Director General of CIRDAP on September 2024, succeeding Dr. Cherdsak Virapat, a Thai national, who successfully completed his four-year term (2020–2024). Dr. Shekara will serve CIRDAP for the term 2024 to 2028.

A landmark achievement for CIRDAP occurred - on 6 September 2024 - the United Nations General Assembly (UNGA) officially declared 6 July as World Rural Development Day. This date, which coincides with CIRDAP's Foundation Day, was chosen in recognition of the organization's long-standing contributions to Integrated Rural Development in the Asia-Pacific region.

The 39th Session of the Technical Committee meeting (TC-39) was held at Hatten Hotel, Melaka, Malaysia from 5-7 August, 2024. The meeting was hosted by the Ministry of Rural and Regional Development, Malaysia. As a part of the 39th TC Meeting, a National Symposium on Rural Planning & Development also was organized at the Dewan Damar Sari, Kompleks F8, Putrajaya on 8 August, 2024. The 34th Session of the Executive Committee (EC) Meeting was held on 4th-5th June 2024 and the 24th Session of the Governing Council (GC) Meeting on 6th June, 2024 in Bangkok, Thailand. The EC-34 Meeting was co-chaired by Thailand and Vietnam whilst the GC-24 meeting was chaired by Bangladesh.

The three thematic programmes and four cross-cutting programmes of work have been implemented to support sustainable and integrated rural development and poverty alleviation through policy formulation and development and inter-governmental cooperation in the region. They are research on rural development and innovation, integrated rural development models; emerging issues on integrated rural development including natural disaster risk reduction, and climate change impacts, & water resource management as the thematic programmes and partnership cooperation and promotion; training & education; information & communication; and gender in integrated rural development as the cross-cutting programmes.

Under the Research division, the 2023 Rural Development Report (RDR) on 'Assessing the Role of Food and Nutrition Security Policies of the CMCs in Helping the Marginalized Poor and Attaining the Relevant SDGs' completed and published in December 2024. Four Research



projects under the Women, Youth, and Rural Development Programme of CIRDAP are going on during this period — 'Capacity Development of Elected Representatives and Officials to implement Gender Responsive Budget at selected Local Governments in Nepal' implemented by CIRDAP & Local Development Training Academy (LDTA), Nepal; 'Action Lab for Inclusion of Transgender and Gender-Variant Youths in Mainstream Livelihood' implemented by CIRDAP & National Institute for Rural Development and Panchayati Raj (NIRD&PR), India; 'Improving Rural Women Sustainable Livelihood through Empowerment in Sericulture Value Chain' implemented by CIRDAP & Agricultural Planning, Economic and Rural Development Research Institute, (APERDRI) IR Iran; and 'Women and Youth Empowerment Programme for Sustainable Inclusive Rural Development in Sri Lanka: A Bottom-Up Approach' implemented by CIRDAP & Hector Kobbekaduwa Agrarian Research and Training Institute (HARTI), Sri Lanka.

Under the Integrated Rural Development (IRD) Models, to date, CIRDAP has exhibited 11 posters of the rural development models at the CIRDAP Exhibitions and Museum on Rural Development (CEMIRD) from Bangladesh, Fiji, India, IR Iran, Malaysia, Myanmar, Pakistan, the Philippines, Sri Lanka, and Thailand (including Lao PDR, Myanmar, Sri Lanka, and Vietnam). CIRDAP also successfully launched its international publication, 'Integrated Rural Development (IRD) Models of Asia and Pacific Region,' on June 19, 2025, at the NIRDPR Campus in Hyderabad, India. The book compiled transformative 32 IRD models to drive sustainable growth across rural Asia-Pacific. Also, through CIRDAP social Media pages (Facebook, X and LinkedIn) regular best practices and IRD models dissemination has been successfully occurred.

Under the Training and Education, CIRDAP under its capacity building activities till the date completed 255 Training Programmes. During 2024, an international collaborative training programme was conducted: CIRDAP- Institute of Kemajuan Desa (INFRA) Training on Rural Tourism towards Integrated Rural Development, 09 – 17 October 2024 (9 Days) held at Penang, Malaysia. Indian Government funded the Tri-Country Training Design Workshop on Cooperatives Management in Asia and the Pacific Region and the Study Visit to Successful Cooperatives in Thailand was held from 10th to 15th November 2024.

Four international training were planned for 2025: Training Programme on 'Disaster Management and Climate Change Adaptation' 12-19 January 2025 in Islamabad, Pakistan; Joint International Training Programme with Ni-msme, India on "Micro Enterprises for Rejuvenation of Rural Economy: Policies, Programmes & Learnings" 23 February to 2 March, 2025, at National Institute of Micro, Small, Medium Enterprises, Hyderabad, India; CIRDAP and NIRDPR Collaborative International Training Programme on 'Innovation in Rural Development: Policies to Practices – Learning', 15th–22nd June 2025 at the NIRDPR Campus, Hyderabad, India; and CIRDAP-NEDAC International Training Programme on 'Startups, Technology, Entrepreneurship & Partnerships for Vibrant Agri-Cooperatives' on 21-23 July, 2025, Bangkok, Thailand. It is important to note that out of these programmes, two programmes are based on the fully self-financed.



Under Information and Communication division, CIRDAP is regularly organizing Webinars by the eminent professionals on current relevant issues in Rural Development for the benefit of CIRDAP member countries. During 2024, ten (10) webinar on different thematic topics such as Disaster Risk Reduction, Food Loss and Waste, Agricultural Intensification for Family Farming, Small Enterprises, Organized and Unorganized Marketing Channels of Milk Marketing, Artificial Intelligence in farmer's livelihood, Women in Agriculture and Rural Development, Nutrition and Finance and Secondary Agriculture etc. The webinar series in 2025 and beyond has been set and CIRDAP plans to organize at least one webinar in each month. CIRDAP created an official YouTube channel for show casing various activities especially webinars under CIRDAP Knowledge Series. Currently, 40 videos on webinars are uploaded in the channel. During this period, CIRDAP published three international publications titled 'The Rural Development Report (RDR) 2023; and planned for five International publications on 'Rural Tourism in Asia and the Pacific: Concept, Practices and Opportunities', 'Integrated Rural Development (IRD) Models of Asia and Pacific Region', Disaster Management and Climate Change adaptation, Rural Innovations, Agri Value Chain, Inspiring women stories in CMCs and Agri-Startup and Rural Entrepreneurship. CIRDAP regularly published its monthly E-Bulletin 'Voice of CIRDAP', September - December 2024, total 4 issues were published highlighting various facets of IRD in the Asia-Pacific region and activities of CIRDAP with stakeholders. Another flagship publication of CIRDAP Asia Pacific Journal of Rural Development (APJORD) is a biannual professional journal in association with SAGE publication. In this period Volume 34, Issue 2, December 2024 published.

In order to avail the global expertise for assisting CIRDAP in addressing challenges in Rural Development in CIRDAP member countries, CIRDAP has created a platform to network Experts in Rural Development as CIRDAP Experts. On December 18, the CIRDAP Experts' Meeting was held virtually at 11 a.m. (Bangladesh time), with the participation of 26 experts from various disciplines across the CIRDAP Member Countries. CIRDAP Experts have been asked to utilize CIRDAP Project Facilitation facility to submit projects through CIRDAP to donor agencies. Six proposals received by experts are under screening. CIRDAP has partnership with 62 organizations through LOA and MoUs since from the establishment for joining in hand to uplift the integrated rural development mandate of CIRDAP.

CIRDAP undertakes sponsored projects by the CIRDAP member countries and other donors based on their specific requirements in Rural Development. CIRDAP has initiated CIRDAP project Facilitation Centre which provides consultancy proposals from the experts, organizations and examine for relevancy at CIRDAP level. The fundraising was also made through a few research projects in collaboration with development partners, as well as the implementation of relevant activities that can offer the possibility for fundraising. Fundraising activities also have been carried out through the activities at the CIRDAP International Conference Centre (CICC), and submission of collaborative proposals in collaboration with CMCs.

Chapter 1: Introduction

Established on 6th July 1979, the Centre on Integrated Rural Development for Asia and the Pacific (CIRDAP) is an intergovernmental and regional organization created to promote Integrated Rural Development (IRD) across the Asia-Pacific region. CIRDAP emerged in response to the failure of earlier development approaches during the 1970s, a time when rural development began to gain prominence in national development agendas and Strategies. Therefore, the idea of promoting IRD through regional cooperation by establishing an intergovernmental organization in the Asia Pacific Region emerged.

With support from the Food and Agriculture Organization (FAO) of the United Nations, CIRDAP was formed to foster regional cooperation in rural development through a structured and integrated framework. There are 15 member states: Afghanistan, Bangladesh (Host State), Fiji, India, Indonesia, IR Iran , Lao PDR, Malaysia, Myanmar, Nepal, Pakistan, Philippines, Sri Lanka, Thailand, and Vietnam.

CIRDAP's core objective is to promote integrated rural development by enhancing regional cooperation among member states, link institutes, and development partners. It aims to improve the lives of rural people through:

- Development assistance projects
- Capacity building and institutional strengthening
- Policy formulation and research support
- Knowledge dissemination and technical exchange

CIRDAP works closely in partnership with the National Link Institutes and Centres of its member governments, development agencies, Non-Governmental Organizations, farmer associations, research bodies and other organizations with mutually shared principles. CIRDAP supports technical exchange and capacity building, institutional strengthening and the development of policies for Integrated Rural Development.

Organizational Structure (Policy Bodies)


The Centre is administered by the Secretariat based in Dhaka, Bangladesh. CIRDAP has three governing bodies, namely Governing Council (GC), the Executive Committee (EC) and the Technical Committee (TC). The Governing Council (GC) is the highest policy and decision-making body of CIRDAP represented by the Ministers of the designated Contact Ministries of all member countries. It sets the overall policy and programme direction for the Centre. The primary role of the Executive Committee (EC) is to review and make recommendations to GC on matters concerning the management and operation of the Centre's activities. It is also responsible to provide guidance to the Centre on implementation of the policies and decisions. The Technical Committee (TC) is to provide technical advice on professional matters concerning work plans and strategies for implementation of the CIRDAP activities, and the interrelationships and coordination of activities carried out by the Centre under auspices of the member countries.



CIRDAP Secretariat

CIIRDAP Secretariat led by the Director General (DG) who is the Chief authority of the organizations run day to day activities in the head quarter, Dhaka, Bangladesh. It provides technical and policy support to Ministries and Institutions with IRD by enabling national decision-makers, development practitioners and planners to exchange ideas and experiences on IRD and to identify areas in which collaborative efforts can be promoted for the mutual benefit of member states. CIRDAP is mandated to facilitate services that will influence policy formulation and programme development towards rural development and poverty alleviation through a network of CIRDAP Contact ministries and Link Institutions. CIRDAP's 'Core Activities' related to IRD include research, pilot project, training and education, exposure visit, consultative conference/policy dialogue, dissemination of Information, etc.

Leadership in Changes of CIRDAP



Dr. P. Chandra Shekara assumed charge as New Director General of CIRDAP on September 6, 2025, an Indian national replacing Dr. Cherdsak Virapat Thai national who has completed his four-year term (2020 -2024). Dr. P. Chandra Shekara will serve CIRDAP from 2024 to 2028.

Dr. Chandra is a leading Professional in the field of Agriculture with his more than three decades of service towards

integrated rural development especially in the areas namely Agricultural Extension Management, Agri-Entrepreneurship Development, Agricultural Marketing Management and Public-Private-Partnership. He headed three premier National Institutions in India which work for the Ministry of Agriculture and Farmers Welfare, Government of India. Dr. Chandra served as Director General of CCS National Institute of Agricultural Marketing (CCS NIAM), Director General (In-charge) of National Institute of Plant Health Management (NIPHM) and Director General of National Institute of Agricultural Extension Management (MANAGE). As Chief Executive of these Institutions, He leads very important International and National schemes, programs and policy interventions for development of Agriculture through Training, Research, Consultancy, Policy Advocacy, Education, International Programmes, Implementation of Govt. of India Schemes, Agripreneurship Development, Agri. Startups Promotion, Documentation and Dissemination in Agriculture Development.

Dr. P. Chandra Shekara received numerous accolades and recognition for his outstanding achievements worth mentioning – "Extension Leadership Award (2023) in the International Extension Education Conference 2023 (IEEC 2023); "NITTE-Karnataka Bank Limited Lifetime Achievement Award-2019 for driving Agri-entrepreneurship Movement in India" and etc.

Chapter 2: Research Programmes

The Research and Pilot Project Division initiatives of 2024 were conducted according to the Strategic Plan and knowledge generation, focusing on specific areas selected by CIRDAP. The Research activities focused on improving rural marginalized people's standard of living. The main purposes of Research and development:

- To carry out interdisciplinary and trans disciplinary research on integrated rural development and related issues in collaboration with CIRDAP Link Institutes (CLIs), development partners and projects to obtain policy advice and recommendations for improving livelihoods, economic and environment aspects and for achieving SDGs and related frameworks.
- The research outcome provides policy advice and recommendations for policy makers in making better informed choices.

During 1979 to 2024, 212 Research & Action Research Projects were carried out by CIRDAP.

2.1 Research Projects under the Women, Youth, and Rural Development (WYRD) Programme

CIRDAP created the Women, Youth, and Rural Development Programme as a key component of its Gender in Integrated Rural Development work. During the 37th session of the Technical Committee on 9 September 2022, the draft brochure and procedure for the programme were approved. This brochure offers comprehensive details about CIRDAP, its key activities, relevant work programmes, and procedures for advancing gender equality, as well as the empowerment of women and youth from 2022 onwards. In the 38th session held in Lao PDR on 3-4 October 2023, the Technical Committee recommended and Governing Council approved the programme as part of the Proposed Work Programme and Budget for the 23rd Biennium (2024–2025). The Governing Council (GC-24) subsequently approved four project proposals for CIRDAP funding for the 23rd Biennium.

Following are the details of CIRDAP's four Research Projects initiated during the period.

- Nepal Capacity Development of Elected Representatives and Officials to implement Gender Responsive Budget at selected Local Governments in Nepal implemented by CIRDAP & Local Development Training Academy (LDTA), Nepal.
- India Action Lab for Inclusion of Transgender and Gender-Variant Youths in Mainstream Livelihood implemented by CIRDAP & National Institute for Rural Development and Panchayati Raj (NIRD&PR), India.



- IR Iran Improving Rural Women Sustainable Livelihood through Empowerment in Sericulture Value Chain implemented by CIRDAP & Agricultural Planning, Economic and Rural Development Research Institute, (APERDRI) IR Iran.
- Sri Lanka Women and Youth Empowerment Programme for Sustainable Inclusive Rural Development in Sri Lanka: A Bottom-Up Approach implemented by CIRDAP & Hector Kobbekaduwa Agrarian Research and Training Institute (HARTI), Sri Lanka.

2.1.1 Details and Progress of the Research activities of WYRD are as follows

I. Title: Capacity Development of Elected Representatives and Officials to implement Gender Responsive Budget at selected Local Governments in Nepal implemented by CIRDAP & Local Development Training Academy (LDTA), Nepal.

Objective:

- 1. The participants will be able to explain better on the importance and need of gender responsive budget.
- 2. The participants will be able to classify and code GRB in the projects at provincial and local levels.
- 3. The participants will be able to understand the GESI Audit process at local levels.

Progress:





The Local Development Training Academy (LDTA), Ministry of Federal Affairs and General Administration (MoFAGA), Government of Nepal organized the first Training Programme of CIRDAP's Project on "Capacity Development of Elected Representatives and Officials to Implement Gender Responsive Budget (GRB) at Selected Local Governments in Nepal" at Modi Rural Municipality during 19 to 20 December 2024. There were altogether 47 participants including Chairperson, Vice chairperson and other elected representatives. The project aims at sensitizing elected representatives on Gender Responsive Budgeting.

II. Title: Action Lab for Inclusion of Transgender and Gender-Variant Youths in Mainstream Livelihood implemented by CIRDAP & National Institute for Rural Development and Panchayati Raj (NIRD&PR), India



Objective:

- 1. Establish the action lab in order to develop a long-term strategy and a sustainable model for identifying and bridging the livelihood gaps for socioeconomically underprivileged transgender and gender-diverse youths with a focus on people from the rural spaces.
- 2. Encourage creating livelihood entrepreneur role models within the transgender communities in various mainstream domains of work and bring them into India's vibrant start-up ecosystem
- 3. Promote creating employment through enterprise and self-help group developments led by transgender and gender-diverse youths from rural spaces.
- 4. Reduce multidimensional poverty within the target group.
- 5. Develop best practice and other training modules for improving the quality of life of socially ostracized and poverty-ridden transgender youths through resilient livelihoods.
- 6. Engage with various stakeholders, such as government agencies, community initiatives & collectives, transgender leaders, corporate bodies, policy institutions & think-tanks, philanthropic initiatives, etc., to showcase & promote the model for inclusive sustainable development and create awareness around the rights, lives, and livelihoods of transgender and gender-diverse communities.
- 7. Integrate the learning of the action lab into various national and international training modules for dissemination of knowledge and promoting inclusive growth internationally and potentially towards establishing a CoE.

Progress:

NIRD & PR, India has received the fund & soon start the Project activities.

III. Title: Improving Rural Women Sustainable Livelihood through Empowerment in Sericulture Value Chain implemented by CIRDAP & Agricultural Planning, Economic and Rural Development Research Institute, (APERDRI) IR Iran.

Objective:

- 1. Establishing "Rural Women Sericulture Development Facilitator Networks" in three provinces
- 2. Increasing the participation of rural women in sericulture value chain
- 3. Creation of rural women silk producer's organizations and self-help groups
- 4. Formation of virtual networks of silk producer rural women
- 5. Providing technical assistance and training by other institutions such as APO and advanced countries such as Japan and China
- 6. Community-based tourism development on the basis of sericulture value chain
- 7. Standardization, identification and development of collective brands and trademarks



- 8. Development of innovative, appropriate, low-cost and indigenous tools and machines in order to increase productivity with the participation of knowledge-based companies active in the region
- 9. Diversification of silk by-products.

Progress:

CIRDAP is waiting for IR Iran communication for accepting funds. APERDRI will start the activities on receipt of funds.

IV. Title: Women and Youth Empowerment Programme for Sustainable Inclusive Rural Development in Sri Lanka: A Bottom-Up Approach implemented by CIRDAP & Hector Kobbekaduwa Agrarian Research and Training Institute (HARTI), Sri Lanka.

Major objective:

The major objective of the project is to sustainably empower women and youth by providing them with sustainable livelihood options in the Kandapola Central village of Sri Lanka.

Specific objectives:

- 1. To identify existing women and youth issues related to livelihood enhancement in Kandapola Central village.
- 2. To identify potential solutions for livelihood enhancement in Kandapola Central village.
- 3. To develop and implement of community-driven women and youth empowerment plan for Kandapola Central village.
- 4. To evaluate the level of women and youth empowerment.

Progress:

HARTI, Sri Lanka is going to start the field work on the second week of January. For the implementation of the project, HARTI is already provided funds.

2.2 Other Research Activities

V. Title: Revisions to the Code of Conduct for Responsible Fisheries Aquaculture Questionnaire towards GSA Monitoring and Report for Aquaculture Development in Northern Africa

CIRDAP with collaboration of the Food and Agriculture Organization of the United Nations (FAO), implemented a dual-component research project focused on enhancing aquaculture governance and strategic planning. The project addressed two core areas/components:

- 1. Revisions to the Code of Conduct for Responsible Fisheries (CCRF) Aquaculture Questionnaire towards GSA Monitoring; and
- 2. Preparation of a Regional Report on Aquaculture Development in Northern Africa.



2.2.1 Component 1: Revising the CCRF Aquaculture Questionnaire towards GSA Monitoring

This component aimed to revise and align the CCRF Aquaculture Questionnaire with the FAO's Guidelines for Sustainable Aquaculture (GSA). A team of senior technical experts, including Mr. Pongpat Boonchuwong (Thailand), Mr. Supawat Komolmarl (Thailand), and Dr. Mohammed Helal Uddin (CIRDAP), conducted a detailed gap analysis and explored integration opportunities for enhanced GSA monitoring.

2.2.2 A Global Expert Consultation Workshop

The workshop was held from 8–10 May 2024 in Bangkok, Thailand, co-organized by FAO and CIRDAP. The workshop convened 15 international experts from 14 countries, including Australia, Brazil, Canada, Chile, Egypt, Nigeria, Oman, the Philippines, Tanzania, Thailand, Türkiye, Tunisia, the USA, and Vietnam. Valuable contributions to the coordination and implementation of the workshop were made by Dr. Matthias Halwart, Team Leader, Sustainable Aquaculture – Global, FAO; Dr. Cherdsak Virapat, former Director General of CIRDAP. - Identification of key gaps and monitoring opportunities related to GSA.

2.2.3 Component 2: A Regional Report for Aquaculture Development in Northern Africa

This component focused on conducting a comparative policy analysis of national, regional, and continental aquaculture frameworks in Northern Africa, vis-à-vis FAO's Blue Transformation Roadmap. CIRDAP engaged Dr. Curtis M. Jolly, Professor Emeritus at Auburn University (USA), who developed a comprehensive report analysing policy coherence, led the study and development challenges in the region.

Objective:

To support evidence-based aquaculture development strategies in Northern Africa by aligning national policies with FAO's sustainability agenda. This research project significantly contributed to global and regional aquaculture governance by:

- 1) Enhancing the usability and strategic value of the CCRF-Aquaculture Questionnaire for FAO Members.
- 2) Informing policy reform and development strategies in Northern Africa in line with FAO's Blue Transformation.

The collaboration reaffirmed CIRDAP's role as a regional partner in shaping sustainable aquaculture systems and advancing responsible fisheries management.

5.1 Breakfast meeting with the Ambassadors of the Embassies in Bangladesh to sensitize on the World Rural Development Day





On 22nd February 2024, the Ministry of Foreign Affairs (MOFA), the Government of the People's Republic of Bangladesh, and CIRDAP jointly organized a breakfast meeting on the 'Declaration of the World Rural Development Day' at the CIRDAP secretariat. Former Ambassador Mr. Masud Bin Momen, Foreign Secretary (Senior Secretary), Ministry of Foreign Affairs, Bangladesh, presided over the meeting. The Heads of Missions of the High Commissions/Embassies of the Member States of CIRDAP in Dhaka gracefully attended the meeting to discuss the draft resolution titled "Declaration of the World Rural Development Day" to be tabled at the UN General Assembly.

Dr. Cherdsak Virapat, the former Director General (DG) of CIRDAP, welcomed the distinguished ambassadors, high commissioners, and their representatives and expressed his gratitude toward them. He briefly discussed the importance of a day like World Rural Development Day. In his opening remark, former Ambassador Mr. Masud Bin Momen expressed that the proposed UN General Assembly Resolution on the declaration of 'World Rural Development Day' can be part of a coordinated strategy to demonstrate the shared commitment to leaving no one behind in our rural areas. He also said that this could be a collective appreciation to CIRDAP by internationally earmarking the date it was established, i.e., 06 July, as the 'World Rural Development Day.'

The meeting ended with a fruitful and interactive open discussion by the honorable attendees and with the closing remark of Ambassador Mr. Masud Bin Momen. He thanked the ambassadors and high commissioners for their contributions and support.



5.2 UNGA Declares 6 July as the World Rural Development Day in Recognition of CIRDAP's Contribution

- On 6 September 2024, the United Nations General Assembly (UNGA) officially declared 6 July as the World Rural Development Day (every year), in recognition of the significant contributions made by CIRDAP in advancing rural development across the region. Notably, this date also marks CIRDAP's Foundation Day, underscoring the organization's enduring commitment to inclusive rural progress.
- The World Rural Development Day (WRDD) website, initially launched on 6 July 2023, has been activated and updated with highlights from the 2024 celebrations. This year, seven events were organized to commemorate the occasion, each reflecting the growing global momentum toward rural transformation and empowerment. These events are now featured on the WRDD website to document and share best practices and innovations in rural development.
- Looking ahead to 2025, CIRDAP is planning to launch a dedicated signature campaign in 2025 to build widespread support and recognition for rural communities in observance of World Rural Development Day.

7.1 Tri-Country Training Design Workshop on Cooperatives Management in Asia and the Pacific Region and the Study Visit to Successful Cooperatives in Thailand at Thailand

Indian Government funded The Tri-Country Training Design Workshop on Cooperatives Management in Asia and the Pacific Region and the Study Visit to Successful Cooperatives in Thailand was held from 10th to 15th November 2024. Upon approval, the project leader will have the opportunity to implement the initiative as Team Leader under the CIRDAP platform, with operational arrangements determined according to project requirements.

Through its *Project Facilitation Centre,* CIRDAP offers customized consultancy services tailored to the specific needs of its member countries. These services are developed in close collaboration with MoU partners and Link Institutions, ensuring contextual relevance and alignment with national development priorities. Project implementation is carried out upon the successful acquisition of donor funding, ensuring both sustainability and effectiveness.






8.2 Asia-Pacific Journal of Rural Development (APJORD)



All the three journals have been circulated to 1.18 lac stakeholders in CIRDAP member countries.














16.3 Communications with the policy bodies




Sources of funds

- (i) **General Fund (GF)** Regular contribution from the CMCs for the administrative and programme support budget;
- (ii) Trust Fund (TF) Grants from the donor countries/agencies for programmatic activities;
- (iii) Regional Cooperation Fund (RCF) Voluntary Contribution of Member Countries for specific programme purposes; and
- (iv) **Corpus Fund (CF)** Generated from Auditorium and Cafeteria income. Only interest earned is utilized for programme purposes.
- (v) Working Capital Fund (WCF) The fund established by the Governing Council to finance budgetary appropriations pending receipt of Member's Contributions and for such other purposes as may be authorized.
- (vi) **Special Reserve Fund (SRF)** Funded out of interest earned on investment of Trust Funds to finance projects for which funds cannot be arranged from other sources.
- (vii) **Depreciation Reserve Fund (DRF) -** Established for replacement of old furniture, equipment, vehicles, etc.
